## Checklist for Oral Sedation With Versed

### Oral Sedation: In Office Treatment

Health and Physical form completed by pediatrician and returned to our office *no later* than the day prior to your child's scheduled appointment. Your child's physical **must have been completed within the last 6 months** – otherwise, a new physical is required. Your child's pediatrician or physician is responsible for completing this form and returning it to our office.

Information and consent forms must be signed and returned to the office prior to patient treatment. This includes your treatment plan which may be susceptible to change on the date of treatment due to your child's specific dental needs. Keep in mind that delayed treatment may lead to further progression of dental caries.

Your child *must be healthy (no fever, heavy congestion, etc.) for 24 hours prior* to the appointment. If there are any questions with regard to your child's health prior to treatment, please call our office or your child's medical doctor. If you need to reschedule your child's appointment due to health concerns, family emergency, etc. please contact our office as soon as possible.

*Absolutely nothing to eat or drink (this includes no water or food) after midnight*, the night prior to the procedure. Once you've put your child to bed there should be no further consumption of any liquids or solids for the safety of your child during treatment.

A \$50 deposit is required at the time the appointment is scheduled. This deposit will be applied to your total out of pocket expenses. The deposit will be forfeited for cancellations less than 48 hours prior to the scheduled appointment.

If you need an estimate of out of pocket expenses, please call our office or your dental insurance carrier. We will file a pre-determination voluntarily as a courtesy to your dental insurance prior to services. Sometimes this can take as many as 30 business days for your insurance to complete. Please notify our office promptly if there are any changes to your dental insurance so that we can submit a correct pre-determination for services.

Any changes in treatment or scheduling of treatment for oral sedations needs to be carried out through Melissa. She will be most familiar with your case and able to address any concerns.

Payment for your portion (the amount not covered by your dental insurance) will be expected on the date of treatment.
